



Competition Terms and Conditions

1) These terms and conditions apply to the competition “Win £30 worth of logs and kindling”, owned and run by Salisbury Gas Shop. By entering a Competition, entrants agree to be bound by its rules (outlined below). Entries open at 10am on Wednesday 6th October 2020 and close at midnight on Tuesday 27th October 2020.

2) Rules specific to the competition will be made available on request to Salisbury Gas Shop.

3) Salisbury Gas Shop reserves the right to cancel or amend the competition or the rules without notice in the event of an event outside of reasonable control. Any changes will be posted either within these terms and conditions and across competition channels.

Qualifying Criteria

4) All entrants must be aged 18 or over and a resident of the United Kingdom. By entering the competition Salisbury Gas Shop assumes that the entrant consents to entering, and has read and agrees to, the competition terms and conditions.

5) By entering the competition, entrants agree to have their name and their chosen photograph published on social media in the event of being selected as competition winner. Should the owner of the photograph be someone other than the entrant, we ask that all entrants gain the permission of the photographer prior to submitting their entry. Entrants’ entry comments, photos or messages may be used for promotional purposes by Salisbury Gas Shop.

6) Individuals employed or contracted by Salisbury Gas Shop or associated companies or promotional partners are not eligible to enter the competition. Similarly, families of those employed or contracted by any of the above are also ineligible to enter the competition.

7) Entrants must live within 10 miles of Salisbury, Wiltshire.

8) Salisbury Gas Shop reserves the right to disqualify any entrant if it has reasonable grounds to believe the competition rules have been broken.

9) In the event that the winner is subsequently disqualified from the competition, Salisbury Gas Shop in its sole discretion may decide whether a replacement should be selected. In this event, any further entrant will be selected on the same criteria as the original entrant and will be subject to these rules.

- 11) Only one entry per person. Any additional entries will not count and may result in disqualification if it believed that an unfair advantage is being actively sought by an individual.
- 12) There is no purchase requirement to enter the competition. There is also no requirement to be a customer, past or present, of Salisbury Gas Shop.
- 13) Entry to this competition is free of charge. There is no cost associated with entering this competition, winning, or claiming the prize if selected as the winner.
- 14) In all matters the judges' decision(s) will be final and Salisbury Gas Shop has no obligation to enter correspondence or discussion.
